Through personal discussions in which goals and objectives based on a client's particular circumstances are established, we develop a client's personal investment policy and create and manage a portfolio based on that policy.</li> <li>Monitoring</li> <li>We review the performance and allocation of each client account periodically, with such reviews occurring no less frequently than on a semi-annual basis. Factors that may trigger more frequent reviews include material market events or changes in a client's personal situation.</li> </ul>
	<ul> <li>Investment Authority</li> <li>We will manage advisory accounts on a discretionary or non-discretionary basis.</li> <li>Limited Investment Offering</li> <li>We do not limit our advice to proprietary products, or a limited menu of products or types of investments.</li> </ul>
	Account Minimums and Other Requirements We require a minimum account of \$500,000 or a minimum annual fee of \$5,000 for investment services. This account size and minimum fee may be negotiable under certain circumstances. We may group certain related client accounts for the purposes of achieving the minimum account size.

We charge clients an investment management fee that is based on the value of each client's assets under management. Assets under management from \$0 to 1,000,000 pay an annual fee of 1.25% and assets over \$1,000,000 pay 1.00%. In certain circumstances, all fees and account minimums may be negotiable.
	In addition to advisory fees, clients are also responsible for the fees and expenses charged by custodians and imposed by broker-dealers. Such fees may include, but are not limited to, any transaction charges, fees for duplicate statements and transaction confirmations, and fees for electronic data feeds and reports. All fees paid to us for investment advisory services are separate and distinct from the fees and expenses charged by mutual funds to their shareholders. These fees and expenses are described in each fund's prospectus. These fees will generally include a management fee, other fund expenses, and a possible distribution fee.
