THE BROOKMONT CORE DIVIDEND STRATEGY

is a core strategy of 30-45 individual common stocks that seeks a competitive total return by investing in equity securities that provide a balance between current income and income growth with the potential for long term capital gains, lower volatility and downside risks.

INVESTMENT PROCESS

The firm utilizes its bottom up process facilitated by quantitative screens of fundamental characteristics to narrow the selection universe. Further fundamental analysis is performed incorporating Brookmont's macro investment themes to arrive at our proprietary dividend score.

PORTFOLIO STRUCTURE

- Typically between 30-45 holdings
- Weightings range from 1.25% to 3.75% at time of addition
- Strategy typically invests in 11 sectors of the market as defined by the S&P 500
- Maximum sector weight of 20%
- Strategy may invest in ADRs
- Low internal correlation between holdings
- Low turnover typically 5-20%

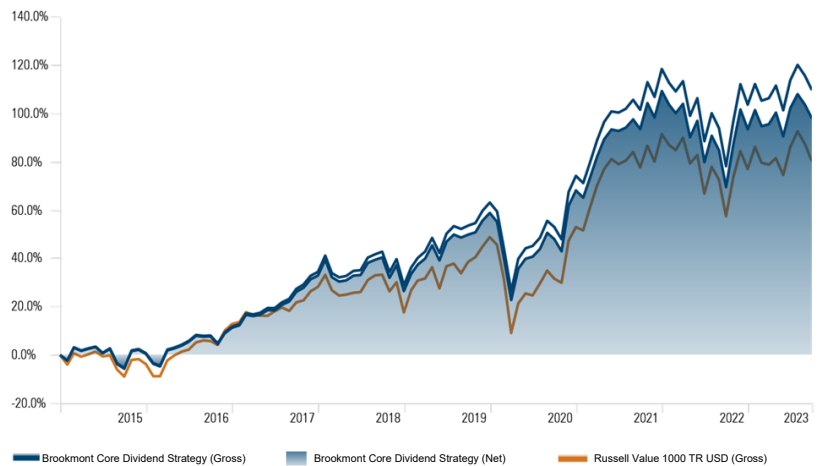

CUMULATIVE PERFORMANCE Jan. 2015 – September 2023

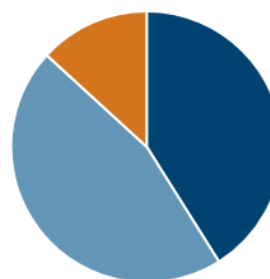

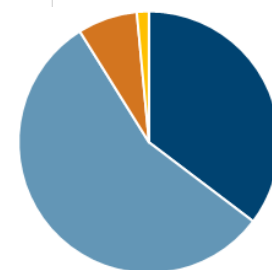

The Russell 1000 Value Index is constructed to provide a comprehensive and unbiased barometer for the large-cap value segment. The benchmark is the Russell 1000 Value and was changed on October 1, 2020 from the Russell 1000 Index.
